1. Students should apply to the Divisional Secretary,..... Divisional Board,..... if their address is changed before the Final Eligibility Certificate is issued to them they should communicate the change in the address forthwith.
2. Marks a tick against the appropriate items, in column 6 for documents attached with this form.
3. Unless all the above mentioned documents are produced the Final Eligibility Certificate will not be issued.
4. Fee for Eligibility Certificate
 - i) Rs. 500/- (For students coming from Others States Board of India)
 - ii) Rs. 700/- (For students coming from Outside India)
5. Eligibility Certificate shall be issued by the Board to student through the Junior College on or after 15th November with late fee.
6. If on Scrutiny of the application for Eligibility Certificate the enclosed documents it is found by the Board that the students is not eligible for admission to the Junior College class the student shall be informed accordingly by the Board through the Junior College on or after 15th November.
