I am to refer to your letter No.UBF 1080/6260/UNI-2,  
dated 9th November, 1981, on the abovementioned subject and to  
state as under.

2. This office had sent to the Government the proposals that  
were received for permanent/continuation/continuation and extension  
extension of affiliation of colleges from the academic year 1980-81  
vide this office letter No.Aff/Recog./3056, dated 14th March, 1980.  
The proposal of the abovementioned college was listed under the  
following heading :

"List of colleges which have applied for continuation  
of affiliation/extension of affiliation as these  
colleges have affiliation for teaching the courses  
of study for the First/Second year examination  
leading to the concerned degrees; the affiliation  
will have to be extended to enable them to come up  
to the degree level."

3. This college having been established in 1979-80, in which  
year it had First Year B.A., B.Sc. and B.Com. classes, the exten-  
sion for 1980-81 for having Second year B.A., B.Sc. and B.Com. class  
came into the category of 'extension as natural growth process'.  
Thus the prior approval of the Government for processing the  
application of this and other colleges mentioned in the first  
category of the list sent with this office letter dated 14th March,  
1980, referred to above did not arise.

4. As stated in para 1 of page 4 of this office letter No.Aff/  
Recog/2829, dated 7th March, 1980, since the coming into the force  
of the Bombay University Act, 1974, it was then for the first time  
that the Government had asked the Executive Council to scrutinize  
each application received for permanent/continuation/continuation  
and extension/extension of affiliation from the academic year  
1980-81; to send to the Government the result of the scrutiny in  
respect of each application and to appoint local inquiry committees  
only after receiving Government's approval. In view of what was  
stated in the said letter in connection with the above matter, the  
Government was requested not to insist on the requirement of prior  
approval for processing the applications in view of the provision  
of Section 44 of the Act.

5. Anyway, the proposal of the above college being of the category of 'natural growth process', the same was not included in the other proposals for 1980-81 sent to the Government and listed under the category of applications received for purely extension of affiliation. The Government appears to have taken into consideration this fact because it conveyed to this office its approval for further processing of the applications for extension of affiliation of the colleges from 1980-81 and did not say anything about the approval to the other proposals sent to the Government for continuation and extension of affiliation from 1980-81 vide your letter No.UBF 1080/5174/XXV, dated 3rd July, 1980.

6. Lastly, permission for processing further the application of the abovementioned college for continuation and extension of affiliation from 1981-82 having been approved by the Government (vide letter No.UBF 1081/5564-UNI-2, dated 24th August, 1981), it is necessary that a notification for the continuation and extension of affiliation of the said college for the earlier year namely 1980-81 is issued.






